



## **Università degli Studi Messina, Italy**

### **DOCTORAL EDUCATION - XXVIII CYCLE - SELECTION PROCEDURE ANNOUNCEMENT FOR FOREIGN STUDENTS FROM COUNTRIES OUTSIDE THE EUROPEAN UNION RESULTS**

The Senato Accademico of the University of Messina met on 2 February 2013. According to the regulations of the "Doctoral Education - XXVIII Cycle - Selection procedure announcement for foreign students outside the European Union" (Rector Decree 2695/2012) published on Italian Official Gazette (Gazzetta Ufficiale 4^Serie Speciale n° 91, 20 November 2012), and on the basis of the evaluation criteria adopted by the Examining Commission, the attached Final List (annex 1) has been approved.

The evaluation criteria are listed below:

- a) Qualitative and quantitative relevance of academic and professional qualifications (up to maximum of 8 points)
- b) Recommendation letters by University professors in Italy or abroad (up to maximum of 2 point: 0 point for no letter, 1 point for one letter, 2 points for two letters)
- c) Relevance scientific publications (up to maximum of 5 points).

In case of equal score, the youngest applicant is selected.

The winners, who have already communicated their acceptance, must complete their enrolment at their arrival in Italy. They must hand over the following documents to Università degli Studi di Messina *Settore Alta Formazione, Ufficio Dottorati per cittadini stranieri, perfezionamento estero e borse (DIREZIONE SERVIZI DIDATTICI, RICERCA E ALTA FORMAZIONE, Area Alta formazione, Ricerca e Relazioni Internazionali)* Via Consolato del Mare 41, second floor, Messina, Italy:

- a) enrolment form which will be available on the University website at link <http://www.unime.it/ateneo/bandiconcorsi/dottorati.html>;
- b) original certificate of the University qualification obtained abroad or equivalent, with translation into Italian certified by the competent Italian Embassy or Italian Consular Office;
- c) "Dichiarazione di valore in loco", an official document providing all the details of the academic career of the candidate, issued by the competent Italian Embassy or Italian Consular Office of the country where the qualification was awarded, and its certified translation in Italian;
- d) the Stay Permit issued by the Italian local police station (Questura). All details and procedures can be found on the web site of the Ministry of Foreign Affairs (<http://www.esteri.it/visti/>);
- e) photocopy of a valid identity document;
- f) a passport photo.

Doctoral students must also hand over to the University of Messina within 10 days from enrolment:  
1. Italian tax code; 2. health insurance and social security (doctoral students should open an INPS account filling out a "Gestione separata dei Lavoratori Autonomi" form available at any INPS office in Italy - Italian social security institution).
